- CDL new rules, new program
  - Hillsboro (Joshua Ellis email): the CDL program is that Hillsboro is going with a hybrid method of training, utilizing an outside company for the materials portion

and our own staff for drivers trainers. Our superintendent, Justin Jensen, is working on this along side of our Risk management department. More to come on this once it's all ironed out.

- o The members present talked about:
  - Working with the unions to negotiate probationary periods to allow new hires to obtain their CDL.
  - How to address new hires leaving after obtaining their CDL and the employer's cost to put them through the classes, is there a pay-back program?
  - How are employers addressing promotions with CDL requirements,
  - Most employers are having to send people to the commercial schools rather than being able to afford to train in-house, and schools are full and that leads to 6-month wait times
  - An additional impact is that people do not have enough time to become
    proficient at something within their probationary period due to the
    month-long driving school taking them away from their ability to learn
    other aspects of their job.
